CALL TO ORDER

Chairman Chris Cavanaugh called the meeting to order at 11:15 a.m.

MINUTES APPROVED

Doyle Parrish motioned for approval of the May 13th, 2008 board meeting minutes. The motion was passed unanimously.

COMMENTS FROM THE CHAIRMAN

STATE OF THE INDUSTRY

- 2007 Visitor Spending
 - o The Division released the 2007 county by county visitor spending numbers.
 - o Ninety-four out of 100 counties showed increases in visitor spending.
- Occupancy
 - o Smith Travel Research information through July shows that average room rates remain strong at \$84.05 and RevPAR is stable at \$49.37, while overall occupancy rate is down 4.5 percent year to date.
- Budget Update
 - o Lynn presented an overview of the Division's budget. She noted that recent legislative changes resulted in 10 percent less funding for marketing (\$1.3 million). She reviewed how funds were allocated for 2007-2008 and listed line items planned for reduction in 2008-2009.
 - Various Board members participated in lengthy discussion following Lynn's presentation. Doyle Parrish, Harris Prevost, and Chris Cavanaugh voiced concern that funds were being directed to support a single project (CIAA Tournament in Charlotte), rather than statewide marketing.
 - Secretary Fain conveyed his support for tourism, recognized its contributions to the state's economy and commended the creativity and collaboration of the state's tourism industry.
 - o Chris Cavanaugh shared an editorial that he wrote regarding the Division's funding, which was published in multiple newspapers across the state.

 - o Division will lead a delegation of twenty-five tourism industry leaders to TIA Travel Leadersip Summit in Washington, DC on September 24th and 25th.

- o ESTO will be held in Bonita Springs, FL from August 22nd through August 26th.
- o Mid Year Marketing Update will be held at the Raleigh Marriott City Center on September 9th.
